General information

Cancellation policy

- Cancellation up to 30 days prior conference beginning: full refund of the fee less a 15% administration fee
- Cancellation up to 10 days prior conference beginning: 50% of the registrations fee will be refunded
- Cancellation from 10 to zero days prior congress beginning: non-refundable, 100% of the registrations fee will be kept

Cancellation of an event/conference

In the unlikely event of cancellation the event/conference by the organizer, participants will be offered a full refund, or a credit note against an equivalent future event/conference.

Terms of payment

EE Impact GmbH will charge your credit card only with the registration fee, but not with costs for accommodation. Please regard that Amex is not accepted.

Please pay your accommodation directly at check out in the hotel. EE Impact GmbH will only forward your credit card details to the hotel in case of a no show or short notice cancellation. If you do not have a credit card, please contact the organizer.

Attestation
